OUR SOLUTIONS

Until recently BEWiSynbra Group used separate systems for registration of data and managing their processes. However, it turned out that Ultimo also offers the EHS-related modules relevant to BEWiSynbra Group in addition to the software they already used. For the sake of efficiency, they chose to continue with Ultimo modules only. Results: a safer work environment, processes that are registered properly and comply with EHS directives and legislation.

For Theo van Maurik, Technical Manager at BEWiSynbra Group, placing everything in one system was a major advantage: "We generated reports and KPIs manually and did not have a whole lot of verification and validation methods. We very much wanted to have a more efficient solution." BEWiSynbra Group's work permits, Management of Change (MoC) and EHS incidents are now no longer processed in separate systems. The best approach for conversion was determined per module.

A perfect copy was made of the work permits, which was then exported to Ultimo. Training employees to use the system turned out to be an important issue in the implementation. Van Maurik: "You can't just tell them to start working with it. That won't work..."

Another tip: "Include the end user in the process at an early stage so the acceptance of the changes is much higher." For MoC they chose a step-by-step implementation. The gradual transition worked very well for BEWiSynbra Group. The EHS incidents, on the other hand, are still being reported the old-fashioned way and entered manually. "We are still seeing some resistance against filling in all information in Ultimo." he explains. "Our goal for the future is that reporters can enter the data in Ultimo themselves in an accessible way, preferably via a mobile device or without having to log in."

BEWiSynbra Group is already reaping the rewards of proper registration. The automated modules help ensure flexibility and that the correct procedures are followed. It is now easy to adapts and link processes. In the near future, BEWiSynbra Group would also like to start working with the modules LOTO (Lockout-Tagout), TRA (Task Risk Analysis) and Shift Handover.
